**4. Mayors Comments.**

- a. The Budget was not approved at the Budget Hearing; the next workshop will be Sept. 16, 2010 and the Budget Hearing if necessary will be Sept. 23, 2010 at 6:00 p.m.
- b. The City of Weston Lakes received a Certificate of Appreciation from the Census Bureau
- c. Vandalism in Weston Lakes in 5 or 6 yards. The Sheriff's department investigated. Several days later another home was vandalized. Parents must police their children. Mr Buestring (from the POA) said they were picking up patrols. General consensus is now that school has started the kids will not have time to be bored and the problem will ease.
- d. The Mayor is checking with several auditors to get quotes to have a City Audit done on the books. Mr. Alan Sanderson from Sanderson, Knox & Co. was in the meeting with a packet of information for the Council.
- e. The City received its revenue checks from Center Point Gas and AT&T
- f. The Women's club will be sponsoring their first Walk-A-Thon on SAT, Sept 18, 2010.

**8. Report by Alderman Aldrich**

- a. Emergency Preparedness is thriving.
  - Caroline Flowers and Linda Harnest hosted “bagging parties” to stuff EOC information and door hangers into HEB bags for the CERT teams to deliver.
  - NIMCAST training required via online courses. Must have 100% participation to get grants from FEMA.
  - We are in the 90 day protest period for the new FEMA FIRM maps. Alderman Aldrich to meet with the Engineer and Flood Plain Administrator to discuss and administer a protest.
- b. PIER Center. Public Information Emergency Response – a website or information. Charter paid for through grants. It would be a regional site for Weston Lakes, Simonton and Fulshear. Alderman Aldrich recommended the City’s participation
