An election is hereby ordered to be held on November 3, 2009 for the purpose of electing a Mayor, 5 Aldermen and the City Marshal. Term of office for the Mayor will be for two years. The term of office for the Marshal will be for one year. The terms of office for Aldermen will be determined by lot after the election with two Aldermen serving for two year terms and three Aldermen serving for one year.
